CONDITIONS

- 1) BHYC reserves the right to refuse to haul out any boat it judges the cradle or trailer onto which it will be placed may pose a safety hazard. Boats will not be placed on non-folding or wooden cradles which are no longer accepted.
- 2) A copy of a current Insurance Policy or Certificate of Insurance must be provided with the applications. **NO EXCEPTIONS.**
- 3) All cradles and trailers used for winter storage must carry owner identification and have the bow/stern marked.
- 4) Boat Owner or a designated representative **must be present** at haul out.
- 5) Masts must be removed from your boat prior to haul out. Masts cannot be stored on the boat. This also applies to boats being trailered away.
- 6) Boat owners working on their boats while stored on Club premises must comply with the relevant health and safety regulations and must ensure that any dust, liquid or gas so produced is completely contained within their own storage space.
- 7) Extension cords may not be plugged in during storage when your boat is unattended.
- 8) Applications will be processed on a first come - first serve basis.
- 9) Members accounts must be in good standing for haul out application to be processed and to reserve a spot in the yard.

READ AND UNDERSTOOD

I _____ have read and understood the conditions of this application. In signing this agreement I agree to those conditions, and furthermore undertake to have launched my boat or otherwise have removed it from the Club property no later than May 2nd 2016, unless a written extension to that deadline has been given by the Vice Commodore - BHYC or a Dry Sail Storage application has been completed c/w payment for the 2016 sailing season.

I also undertake to remove all materials, ladders and tools related to winter storage no later than May 3rd 2016 and I understand and agree that if I do not do so, then BHYC has the right to have such items removed and the cost of their removal and disposal charged to me.

AGREEMENT

I _____ in consideration of the haul out and winter storage of my vessel and the storage of my mast, cradle and trailer, where applicable at Bronte Harbour Yacht Club, the Owner, hereby covenants, undertakes and agrees to indemnify, save harmless and defend the Bronte Harbour Yacht Club, its Directors, staff, agents, workmen, contractors, representatives and others from whom it may be responsible in law from and against any liability for costs, losses and damages whatever sort with respect to property or persons, including death, due in whole or in part to negligence by The Bronte Harbour Yacht Club or by those for whom it is in law responsible.

If the Member's/Owner's Haul Out and Winter Storage contract is not returned to the Vice-Commodore, Bronte Harbour Yacht Club by October 15, 2016, The Club will not guarantee haul and winter storage for the period.
