1. BHYC storage number must be prominently displayed on boat and trailer/dolly.
  2. Storage fees must be paid in full with application.
  3. A suitably sized dolly or trailer used in "dry sailing" the boat is acceptable.
  4. **The Club does not permit storage of trailers or dolly's as a separate item, your boat must be stored in the yard, if you have a combination trailer the trailer must be under the boat or you will be charged for trailer storage. Trailers are not considered racks for canoes or kayaks.**
  5. It is mandatory for all tenants to carry a minimum of \$2,000,000 public liability and property damage insurance as a condition of Dry Sail Storage-provide a copy of your current insurance with this application.
  6. Dry Sailing fees must be paid in full with application. A dry sail position will be confirmed to the applicant.
  7. Use of the Club Crane and Hoist is contingent upon the Member having attended a course authorized by the Club. Crane keys are not to be shared. Use of the Club Crane and Hoist is the sole responsibility of the Member. Please refer to the Club Crane policy.

8. The term of Dry Sail Storage is between May 2, 2017 and October 18, 2017. Failure to remove boats or trailers after October 18, 2017 may result in charges being levied by the Club to cover removal or storage costs. The Club will not be held responsible for any damages incurred as a result of the Club arranging for removal or storage.
  9. It is a condition of your Dry Sailing Slip that your boat be licensed or registered in your name.
  10. Boats are not to be connected to power unless the owner is present. If you wish to connect your boat to shorepower on a daily basis it is an additional \$11.50/foot
