GENERAL CONDITIONS FORMING PART OF THE WET MOORING AND DRY SAILING APPLICATIONS

1. All applications are processed on a first come first served basis
2. Total payment of fees must be included with application. A post-dated cheque (April 20th 2018) is acceptable. The cheque will not be processed until a mooring or yard space has been assigned.
3. It is mandatory that all tenants carry a minimum of \$2,000,000 Comprehensive General Liability. A Certificate of Insurance is be required.
4. Vessels being launched or hauled out with the Club must have lifting points clearly marked on the hull.
5. The term for wet mooring is April 28, 2018 to October 20, 2018 (unless being hauled with the Club).
6. The term for dry sailing including kayaks, canoes and paddleboards is April 30, 2018 to October 20, 2018 (unless storing with the Club).
7. It is not permitted to store a trailer or dolly as a separate item unless a separate charge is paid. Trailers are not considered to be racks for kayaks, canoes or paddleboards.
8. Trailers and dollies must be designed and in good condition for the vessel that they are used for. For safety reasons, the Club reserves the right to refuse the use of a trailer or dolly.
9. The club crane and hoist can ONLY be used by members after having successfully completed the Club Safety Seminar and have received a key for their own use. The key CANNOT be shared with anyone. The use of the crane and hoist is at the sole responsibility of the member.
10. Boats cannot be connected to power unless the owner is on board for the boats in wet moorings or in the yard for boats dry sailed.

I _____ in consideration of a wet mooring or yard space available for my Vessel or kayak or canoe or paddleboard, the Owner, hereby covenants, undertakes and agrees to indemnify, save harmless and defend the Bronte Harbour Yacht Club, its Directors, Staff, Agents, Workmen, Contractors, representatives and Others for whom it may be responsible in law from and against any liability for costs, losses, and damages of whatsoever sort, with respect to property or persons, including death, due in whole or in part to negligence by the Bronte Harbour Yacht Club or those for whom in law it is responsible. I further agree that my vessel including kayaks, canoes and paddleboards must vacate the assigned slip or yard by no later than October 20, 2018, unless storing with the Club.
